- 1. **Tender fee of Rs. 2500/- (Non Refundable)** for exclusive tender be provided through DD in favour of "Junagadh Agricultural University Fund A/c"
- 2. The **EMD** (Earnest Money Deposited) for an amount @ minimum 3% of the cost of the quoted tender amount has to be paid in the **form of FDR only** in favour of "Junagadh Agricultural University Fund A/c", from any nationalized Bank of India or any authorized bank drawn in favour of "Junagadh Agricultural University Fund A/c" payable at Junagadh in the Envelop-1. Quotation without EMD will not be considered. In case of unsuccessful tenderers, the Earnest Money deposit (EMD) will be released after finalization of the tender, while in case of successful tenderers/suppliers the Earnest Money so deposited (EMD) will be released after successful completion of supply.
- 3. Manufacturers must submit the **certificate of registration** as manufacturer in the envelope-2.
- 4. **Authorized dealer/distributor of a company have to submit** a copy of their dealership/ distributorship certificate validated by the company for the Current year for each equipment.
